Give the declaration form to your legal guardian for his/her signature.



3.

Return the signed form with the personal information of the person that will be using the Club, which is required for creating a CityFit account. Please submit the form to customer service at the Club, or put it in the document box which can be found at the Club's entrance.



4.

Wait for an e-mail with your password to the customer zone.



5.

Sign in to your customer zone account to select and subscribe to the membership of your choice.

- 6.** Pay for your membership using your chosen method of payment: card payment or direct debit. Remember, you can only place a direct debit payment on your own bank account.
